Judge Fields welcomed all the guest.

In Re: Approval of Agenda

Judge Fields presented the agenda for the meeting. Magistrate Plummer made a motion, seconded by Magistrate Whaley to approve the agenda as presented, motion carried.

In Re: Approval of Minutes

Fiscal Court Clerk, Marianne Roseberry provided the court with the minutes from the February 14, 2023 meeting. Magistrate Plummer made a motion, seconded by Magistrate Mineer to approve the minutes as presented, motion carried.

In Re: Treasurer's Report

Pendleton County Treasurer, Marianne Roseberry, provided the court with a copy of the treasurer's report for the month of January at the February 14, 2023 meeting. Magistrate Gregg made a motion, seconded by Magistrate Plummer to approve the treasurer's report as presented, motion carried.

In Re: Breath Easy Youth Showcase Presentation and Update

Stephanie Green and Peer Leaders Kendall Purvis, Hope Wissel and Payton Mastin spoke about the air pollution findings in Pendleton County Local Businesses. There is currently no indoor air quality standard. The 2021-2022 park clean up was a success, there was a total of 3534 cigarette butts removed. The goal is to keep the air and the grounds where our children play free from smoke and litter. The leaders spoke about the dangers of second-hand smoke and aerosol exposure. They also talked about what a smoke free ordinance is and why we should support a smoke free policy. 1. 23% of high school students are less likely to smoke. 2.. No economic impact on local business who go smoke free. 3. Tourists prefer to visit areas that protect the environment and welfare of the local people.

In Re: Mayor Ernst and Council - Fire Agreement

Mayor Ernst addressed the court to ask them to consider increasing funding for the fire department since the county use was 74% of the fire calls. Mayor Ernst would also like the get a budget together with the help of the city and fiscal court. Judge Fields asked the

mayor to get numbers together on their current debts on trucks, uniforms, supplies and anything else. Mayor Ernst also stated the county has a lean on the property of the yellow house on Shelby Street that was recently torn down. The total cost was \$12,000 and he would like the county to consider paying a portion to off set the cost. The court stated they would need to do some research and speak with the County Clerk. No action was taken.
