The meeting was called to order at 6:03 p.m. by Judge Fields. Invocation was given by Magistrate Whaley with the Pledge of Allegiance being led by Judge Fields.

In Re: Recognition of Guest

Judge Fields welcomed the Boy Scout and Cub Scout Troops and Leaders.

In Re: Approval of Agenda

Judge Fields presented the agenda for the meeting. Magistrate Plummer made a motion, seconded by Magistrate Mineer to approve the agenda as presented, motion carried.

In Re: Approval of Minutes

Fiscal Court Clerk, Marianne Roseberry provided the court with the minutes of the March 9, 2021 Meeting. Magistrate Plummer made a motion, seconded by Magistrate Whaley that the minutes be approved as presented, motion carried.

In Re: Treasurer's Report

Pendleton County Treasurer, Vicky King, provided the court with a copy of the treasurer's report for the month of February 2021 at the March 9, 2021 meeting. Magistrate Mineer made a motion, seconded by Magistrate Gregg to approve the treasurer's report as presented, motion carried.

In Re: Motion to go into Public Hearing - CDBG Covid-19 Relief

A Public Hearing was a requirement to apply for the CDBG Covid -19 Relief Grant. Magistrate Gregg made a motion to go into a Public Hearing for a CDBG Covid-19 Relief Grant, seconded by Magistrate Plummer, motion carried. Bill Mitchell, Pendleton County Economic Development Director discussed the money that is available to Kentuckians with overdue utility bills through a CDBG-CV Utility Assistance Program established by HUD. He stated the county would be applying for a \$125,000 grant to provide utility relief to residents of Pendleton County. After a discussion Magistrate Mineer made a motion, seconded by Magistrate Whaley to close the Public Hearing and go back into regular session, motion carried. Judge Fields read the Resolution to apply for the grant and Magistrate Plummer made a motion, seconded by Magistrate Mineer to approve the Resolution, Whaley-Yes, Plummer-Yes, Gregg-No, Mineer-Yes and Judge Fields-Yes, motion carried.

In Re: Bid Opening – Homeland Security Grant

Mike Moore, Emergency Management Director explained to the court that we had been awarded a grant to purchase equipment to link police repeater equipment together. Judge Fields opened the only bid for the equipment from Mobilcomm. Bid # 1 was for \$27,630.40 and Bid # 2 was for \$24,225.00. Magistrate Whaley made a motion, seconded by Magistrate Gregg to accept the bids from Mobilcomm pending the verification of the amounts, motion carried.

In Re: Pendleton County Tourism - Melanie Hartzel

Melanie Hartzel, chairperson of the Pendleton County Tourism presented to the court the plans of the Tourism Council to have the First Annual Pendleton Outdoor Palooza on June 19, 2021 to showcase Pendleton County's outdoor activities. She was asking the court to help sponsor the band for the evening at the Griffin Centre. Magistrate Gregg made a motion, seconded by Magistrate Plummer to donate \$2,500 to sponsor the band, motion carried.

In Re: Resolution for the NK Regional Hazard Mitigation

Judge Fields read the Resolution for the Northern Kentucky Regional Hazard Mitigation Plan for the Cities and Counties in Northern Kentucky. Magistrate Whaley made a motion, seconded by Magistrate Plummer to approve the Resolution, motion carried.

In Re: 2nd Reading Ordinance Amendment 1011.1 – Nuisance Ordinance

Judge Fields gave the 2nd reading of Ordinance amendment 1011.1 to limit the meetings of the Code Enforcement Board. Magistrate Plummer made a motion, seconded by Magistrate Mineer to approve Amendment 1011.1, motion carried.

In Re: 2nd Reading Zoning Ordinance 924.3 – Zoning Change R to B

Judge Fields gave the 2nd reading of Zoning Ordinance 924.3 (Chelsea Heilman) – zoning change from Rural to Business. Magistrate Whaley made a motion, seconded by Magistrate Plummer to approve Zoning Ordinance 924.3, motion carried.

In Re: Reappointment – Brent Moore- PC Water District Board

Magistrate Gregg made a motion, seconded by Magistrate Plummer to reappoint Brent Moore to the Pendleton County Water District Board for a 4 year term, Magistrate Mineer abstained, motion carried.
