- Exterior walls seal coated using bituminous product
- Water stop applied where the walls meet the slab, this chemical reaction will provide protection from seepage typcially provided by the footer key way.
- Pump truck will be supplied

The cost for the services as outlined would be **\$24,000 (Twenty Four Thousand Dollars)**. And the payment regimen would proceed as following:

- 100% of the committed cost at project completion, net-30 terms and conditions, all over-due invoices will be charged a 10% penalty fee.
