Judge Fields called the meeting to order at 6:00 pm.

#### In Re: Agenda

Judge Fields presented the agenda for this special called meeting. Invocation was given by Magistrate Whaley with the Pledge of Allegiance being led by Judge Fields.

#### In Re: 2<sup>nd</sup> Reading of the 2023-24 County Budget

Judge Fields gave the second reading of the revenues and Magistrate Whaley gave the second reading of the appropriations of the 2023-24 Budget. Magistrate Whaley made a motion, seconded by Magistrate Mineer to approve and adopt the 2023-24 County Budget, motion carried.

#### In Re: Bids for Tractor for County Road Department

Judge Fields opened the bid for a tractor for the county road department. The quote was from Wright Implement for \$74,623.03 for a 5100 E cab tractor with extra equipment and \$67,278.92 for a 5100 E cab tractor with basic equipment. The Judge also had a quote on a loader for the tractor for \$5,787.40. Magistrate Mineer made a motion, seconded by Magistrate Gregg to purchase the 5100 cab tractor for \$67, 278.92 and the loader, motion carried.

#### In Re: Road Department Pay Scale

Judge Fields presented a new pay scale for the road department employees. Magistrate Mineer made a motion, seconded by Magistrate Whaley to approve the new pay scale, motion carried.

#### In Re: Appointments to Serve on Reapportionment Committee

Judge Fields presented Terry Logan, Edwin Stahl and Bob Fogle to serve on the reapportionment committee. Magistrate Whaley made a motion, seconded by Magistrate Gregg to approve the three appointments, motion carried.

#### In Re: Culvert Head Work on McKinneysburg Road

Judge Fields presented the quotes for culvert head work on McKinneysburg Road. One was from Wright Contracting for \$7,800.00 and the other English Foundations for \$8,200.00. Magistrate Mineer made a motion, seconded by Magistrate Plummer to approve the quote from Wright Contraction for \$7,800.00, motion carried.
