The meeting was called to order at 6:00 p.m. by Judge Fields. Invocation was given by Magistrate Whaley with the Pledge of Allegiance being led by Judge Fields.

In Re: Recognition of Guest

Judge Fields welcomed the guest.

In Re: Approval of Agenda

Judge Fields presented the agenda for the meeting. Magistrate Plummer made a motion, seconded by Magistrate Mineer to approve the agenda as presented, motion carried.

In Re: Approval of Minutes

Fiscal Court Clerk, Marianne Roseberry provided the court with the minutes of the November 8, 2022 special called meeting and the November 15, 2022 special called meeting. Magistrate Whaley made a motion, seconded by Magistrate Gregg that the minutes be approved as presented, motion carried.

In Re: Treasurer's Report

Pendleton County Treasurer, Marianne Roseberry, provided the court with a copy of the treasurer's report for the month of October 2022-23 at the November 8, 2022 special called meeting. Magistrate Mineer made a motion, seconded by Magistrate Plummer to approve the treasurer's report as presented, motion carried.

In Re: Award Presentation – Anna Mary Tackett

Judge Fields presented an award to Anna Mary Tackett for her service on the Northern Kentucky Council on Aging Board.

In Re: Athletic Park Fencing Improvements – Dugout/Batting Cage Security

Judge Fields presented the athletic park fencing improvements with dugout and batting cage security. Magistrate Gregg made a motion, seconded by Magistrate Plummer to approve Mills Fence Co. to make the fencing improvements to the athletic park for \$12,240.00, motion carried.

In Re: Purchase of Trash Receptacles for the Athletic Park

Judge Fields presented quotes for trash receptacles for the athletic park. Magistrate Plummer made a motion, seconded by Magistrate Mineer to purchase 8 trash receptacles for \$3897.00 and to wait for the concrete pour before they place the trash receptacles, Magistrate Gregg opposed, motion carried.

Eli Mann, Chairman of the Pendleton County Fair Board presented to the Court at the Caucus meeting. He was asking for support from the Court. Magistrate Gregg made a motion, seconded by Magistrate Whaley to give \$15,000.00 plus our normal \$5,000.00 donation to the Pendleton County Youth Fair on a 3-year contract, and to re-evaluate each year, motion carried.
